"all maturation ponds must be lined with high density polyethylene or similar appropriate liners to prevent the pollution of groundwater"

The condition is to be amended to read:

"all maturation ponds must be lined with natural clay to prevent the pollution of groundwater"

2. EA condition G12 – currently states:

"Landscaping on the site must consist of only locally indigenous vegetation. No exotic grasses such as Kikuyu sp. May be used on the site"

The condition is to be amended to read:

"Landscaping on the site must consist of only locally indigenous vegetation with the exception of exotic grasses such as Kikuyu (Pennisetum clandestinum) which occurred on the site prior to development"

The WWTW was constructed on the existing WWTW facility which was constructed prior to the application for the EA as granted on the 15 January 2008. This authorised facility as per the EA issued on the 15 January 2008 was constructed using concrete. The maturation ponds referred to in this condition is in relation with the old constructed WWTW, which is still used on site. The old structure is therefore still in operation. The new WWTW as authorised in the EA of 2008, operates as a separate system and the treated effluent from the new WWTW goes to the old "existing" facility's maturation ponds, where after it is used for irrigation as per DWS approval.

Condition G 12

The landscape that was done on site as per the EA of was done with naturally occurring indigenous vegetation. The site, however, was constructed next to the existing facility which was landscaped with Kikuyu grass. Kikuyu as the more dominant species already established on the site has taken over as a result of irrigation.
