

Provide a <u>full</u> description of the nature and extent of the proposed development or activity including its potential impacts (eg: changes in land use, envisaged timeframes, provision of additional bulk services, excavations, landscaping, total floor area, height of development, etc. etc.): The Swellendam Municipality proposes a subsidised housing project on a Remainder of Erf 1 at Swellendam, comprising of 961 residential erven and 86 GAP residential erven. 4 erven for community facilities. 2 erven for business, 3 for mixed use and 12 erven for public open space. With associated internal roads and associated services infrastructure. Attenuation dams will also be constructed in the non-perennial drainage line. The municipality has confirmed that sufficient bulk services capacities exist for the proposed development (written confirmation and engineer services report still to be provided in EIA).

The proposed 27.08ha development site is unused vacant municipal land.

Site E is a small hill/koppie with steep gradients southeast of the primary school and residential areas of Swellendam South. Previous and ongoing impacts leading to degradation of indigenous vegetation and transformation of the site are the establishment of the water reservoirs and associated pipelines, informal gravel roads and footpaths also leading to alien vegetation encroachment etc. This site is an transformed area and is significantly encroached with alien vegetation species such as especially Acacia saligna and Acacia mearnsii.

Site H is an undulating area in-between the residential area and the railway line of Swellendam South. The site has been completely transformed presumably by previous cultivation activities that took place on the site (exact date of when the area was last ploughed and cultivated is unknown). Little to mainly no indigenous vegetation species have returned to this transformed area and this area therefore has low conservation value and low botanical sensitivity. Although due to the undulating nature of the topography Site H has a slight depression area running basically from one end of the site to the other along the eastern border adjacent to the railway line no evidence of surface water or aquatic vegetation species indicating the presence of a wetland area is present on the site.

Eco Impact Legal Consulting ("Pty") Ltd ("Eco Impact") was appointed as independent Environmental Assessment Practitioners to undertake the Environmental Impact Assessment Process for the proposed development.

This Environmental Authorization is undertaken in terms of the National Environmental Management Act 107 of 1998 and the EIA regulations set out in Government Notice. Listed activities in terms of these regulations have been identified. The nature of the activities to be undertaken requires that a Basic Assessment process be undertaken.

Below is a summary of the some of the main anticipated impacts related to the proposed developments:

- Increased erosion risk due to the clearing of land for the proposed developments;
- Potential impact on a physical characteristics and water quality of a draiange line;
- Biodiversity and especially vulnerable indigenous vegetation impacts
- Social aspects visual and aesthetic quality of the site and surrounds;
- Increased traffic
- Job creation
- Subsidised housing provision

Provide a short history of the site and its environs (Include sources where available):

The sites are underlain by geological formations derived from the Table Mountain group. A prominent geological feature associated with the study area is the occurrence of Silcrete which is an ancient sedimentary rock that has almost entirely eroded during the course of time. It is however a prominent feature of hilltops and undulating plains on the South Coast especially around Swellendam. It is readily identified by the cobbles and pebbles of fine textured rock and also the neutral fine grained substrate that is usually orange-red or even pinkish.

Site E is a small hill/koppie with steep gradients southeast of the primary school and residential areas of Swellendam South. Previous and ongoing impacts leading to degradation of indigenous vegetation and transformation of the site are the establishment of the water reservoirs and associated pipelines, informal gravel roads and footpaths also leading to alien vegetation encroachment etc. This site is an transformed area and is significantly encroached with alien vegetation species such as especially Acacia saligna and Acacia mearnsii.

Site H is an undulating area in-between the residential area and the railway line of Swellendam South. The site has been completely transformed presumably by previous cultivation activities that took place on the site (exact date of when the area was last ploughed and cultivated is unknown). Little to mainly no indigenous vegetation species have returned to this transformed area and this area therefore has low conservation value and low botanical sensitivity. Although due to the undulating nature of the topography Site H has a slight depression area running basically from one end of the site to the other along the eastern border adjacent to the railway line no evidence of surface water or aquatic vegetation species indicating the presence of a wetland area is present on the site. As according to the Overberg Conservation Plan (2010) the site has partially been identified as a Critical Biodiversity Area ("CBA") due to the potential presence of a wetland, threatened species habitat and associated species of conservation concern. The specialist does not agree with the boundaries of the CBA as determined by the Overberg Conservation Plan of 2010, and it is evident from the survey conducted that the CBA status of this area has clearly not been ground-truthed.
