

SUMMARY OF THE PUBLIC PARTICIPATION PROCESS

A newspaper notice was placed in the Carletonville Herald on 18 October 2018 to inform potential Interested and Affected Parties of the proposed development and their right to register as an Interested and Affected Party within 30 days from date of notice.

Adverts were placed in the Carletonville Herald on 18 October 2018

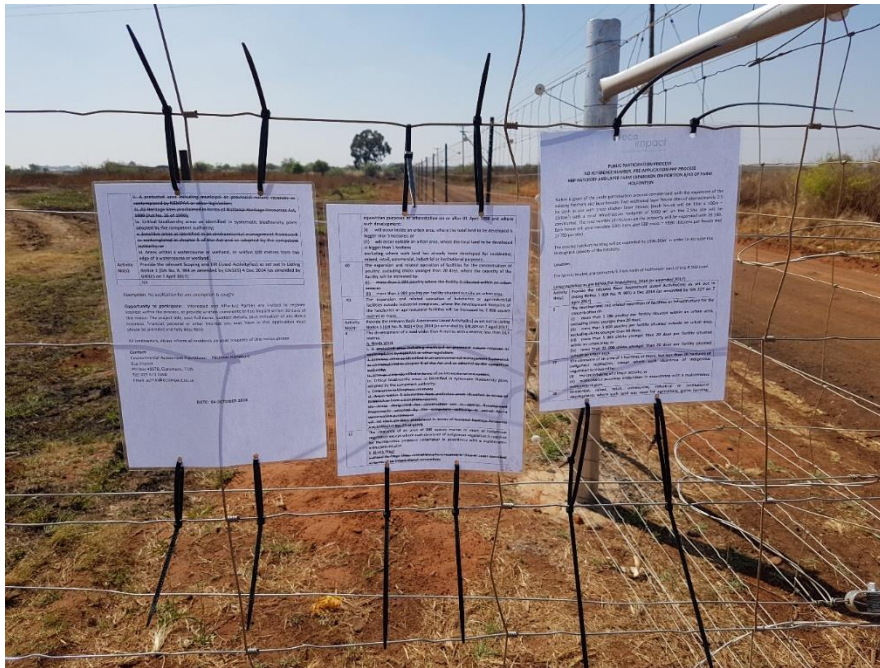
